References are made to (i) the announcement of Beijing Jingcheng Machinery Electric Company Limited (the “**Company**”) dated 6 May 2019; (ii) the circular dated 27 June 2019 (the “**Circular**”); (iii) the poll results announcement dated 15 July 2019; (iv) the announcement dated 25 July 2019; and (v) the announcement dated 9 September 2019 in relation to, among other things, the Proposed A Shares Issue, the A Shares Subscription Agreement and the transactions contemplated thereunder, the Specific Mandate, the Whitewash Waiver and the proposed amendments of the Articles of Association. On 9 September 2019, the Company and Zhong De Securities Company Limited, the intermediary, received the “Notice of First Feedback on the Review of Administrative Permission Items from CSRC” (No. 191997) (the “**Feedback Notice**”) issued by the CSRC in relation to the Proposed A Shares Issue of the Company.

In accordance with the requirements of the Feedback Notice, the Company and the relevant intermediary have carefully studied and responded to each of the questions raised in the Feedback Notice; details of the reply are disclosed in the “Reply To Feedback Of Application Documents For Non-Public Issuance Of A Shares Conducted by Beijing Jingcheng Machinery Electric Company Limited” (《關於北京京城機電股份有限公司非公開發行A股股票申請文件反饋意見的回覆》) published on the website of the Shanghai Stock Exchange (www.sse.com.cn) as well as the relevant overseas regulatory announcement published on the website of the Stock Exchange by the Company on the date of this announcement. The Company will submit the materials regarding the reply to the CSRC within two working days after the publication of the abovementioned reply.

**The completion of the Proposed A Shares Issue is subject to the satisfaction of other conditions, including the obtaining of the approval from the CSRC. Accordingly, the Proposed A Shares Issue may or may not proceed. Shareholders and potential investors are advised to exercise caution when dealing in the Shares, and are recommended to consult their professional adviser if they are in any doubt about their position and as to actions they should take.**
